- 3 years of successful employment as a licensed Cosmetologist

### **GENERAL DUTIES**

The Cosmetology Instructor is responsible for teaching all phases of the Cosmetology program to include sterilization, sanitation, and bacteriology; shampooing, rinsing and styling; hair and scalp care; manicuring and nail care; hair shaping; permanent waving; facials, arching, lash and brow tinting; hair coloring, bleaching, toning and lightening; anatomy, physiology, and chemistry; shop ethics, interpersonal skills, and sales; Tennessee Cosmetology Law; finger waving and pin curls; blow drying and curling irons; permanent waving; hair relaxing; dispensing supplies and desk operations; and computer salon applications. Must be able to coordinate practical experiences and manage patron services. Candidates must participate in professional development activities as needed to learn new techniques and trends in the industry. Other duties include curriculum development, student recordkeeping, student recruitment, placement and follow-up of program graduates, and budgeting.
