MINIMUM ACCEPTABLE QUALIFICATIONS:

- Associates degree required, Bachelor's degree preferred.
- Minimum of two years' work experience in customer service, recruitment, marketing, or related experience; specific experience in higher education preferred.
- Strong customer service skills: must possess effective oral and written communication skills to accurately convey college information and to effectively present information to large groups and individuals.
- Must have the ability to establish and maintain effective interpersonal working relationships with high schools, colleges, prospective students, business and industry, faculty, staff and the general public.
- Must have ability to utilize Microsoft Office programs, audio/visual equipment and software; and working knowledge of maintaining student records and/or sensitive information.
- Must have the ability to multitask with good organization and planning skills.
- Passionate belief in the power of education along with the desire to help students achieve their academic, professional, and personal goals.



GENERAL REQUIREMENTS:

- Will be responsible for dual enrollment in Davidson County Schools.
- Provide career counseling to assist students with selection of proper courses of training.
- Provide assistance with the admissions process for dual enrollment: college application, completion of dual enrollment grant, and other required documentation.
- Maintains a student tracking system and keeps accurate records of dually enrolled students including attendance, grades, and progress.
- Will work with County School Systems to identify additional pathways for articulation for dual enrollment with TCAT Nashville.
- Attend recruitment events such as College and Career Fairs.
- Will be responsible for promoting awareness of TN Promise to high school seniors.
- Perform other duties directly and uniquely related to career and technical education as assigned by supervisor and/or administration, on and off campus.
- Applicants may be subject to a background check.
